THE ADVANCE WARRANTY

For a period of two years from date of shipment from the Company's plant, the Company agrees to replace or repair, free of charge, any defective parts, material or workmanship on new equipment. This shall include electrical and hydraulic components.

For a period of ten years from date of shipment from Company's plant, the Company agrees to replace or repair any defective structure.

Company authorization must be obtained prior to the commencement of any work. The Company reserves the right of choice between effecting repairs in the field or paying all freight charges and effecting the repairs at the Company's plant. The Company further reserves the right of final determination in all warranty considerations. Evidence of overloading, abuse or field modification of units without Company approval shall void this warranty. No contingent liabilities will be accepted.

ALONG WITH THE BEST WARRANTY IN THE BUSINESS, EVERY PERIODIC MAINTENANCE INSPECTION INCLUDES:

- Raise the lift to full height to check the operation and clear any oil buildup from the cylinder housings.
- Clean debris from pit, or under dock lift
- Examine hydraulic hoses for wear or damage
- Check that main axle retaining rings are in place and seated
- Check main axles bushings for wear
- Check main axle pins for wear
- Inspect roller wheels for signs of wear, flat spots and sticking
- Check that all wheel pin retaining clips are in place and seated properly
- Check wheel pins for wear and damage
- Inspect cylinders for leaks
- Inspect cylinders for properly seated retaining clips
- Inspect cylinder mounting pins for signs of wear
- Examine hydraulic fittings for cracks or leaks
- Inspect handrails for cracks or damage
- Inspect safety chains
- Check travel limit switches for proper function
- Examine bridge hinge for cracks or broken welds
- Inspect bridge chains
- Lubricate bridge hinge
- Inspect hydraulic fluid level and check for contamination*
- Inspect power unit for leaks
- Inspect suction filter
- Check breather filter
- Inspect pushbutton for proper function
- Inspect operator cord for wear and damage

***Advance Lifts recommends that you have your hydraulic oil changed annually.**
